- 25% of the shares underlying the option vest in equal monthly installments over the twelve-month period beginning on the second anniversary of June 21, 2018, and ending on the third anniversary, with the remainder vesting monthly over the twelve-month period thereafter, subject to the reporting person's continuous service with the Issuer as of each vesting date, and subject to accelerated vesting in specified circumstances.
